

You've been helping us fight HIV for over 30 years

When Terrence Higgins Trust first opened in 1982, HIV was a death sentence. There was a pervading sense of fear, ignorance and hatred with gay men becoming the particular focus for brutal physical and verbal attacks.

Those initial years - when HIV was first isolated, described and diagnosed - fueled action. Thanks to a global effort in research, combination antiretroviral therapy became the standard treatment for HIV from 1996. Now, those diagnosed with HIV can live long and healthy lives. And there's more. Treatment can push levels of HIV so low that tests show it's at 'undetectable' levels. This means they can be confident they won't pass the virus on to others.

Recently, you helped us campaign for Pre-exposure prophylaxis (PrEP), a course of HIV drugs taken before sex to reduce the risk of getting HIV. We protested against cuts to essential services for people living with HIV and made progress in our campaigns for human papilloma virus (HPV) vaccination for boys, and for a review of blood donation rules.

An HIV diagnosis can be a deeply traumatic experience for many people, despite the advances in treatment. This is largely because stigma has a huge impact on people with HIV, and that's just not right. Despite some shifts in public attitudes, living with HIV still affects anything from employment prospects and financial stability to relationships and physical health. Around a guarter of people living with HIV are unemployed.

Many people have revealed to us that they feel shame, guilt, low self-esteem and self-blame just because they are living with HIV. Some people avoid GP care because they are concerned they will be treated differently. Sadly, nearly one in four had experienced suicidal thoughts in the last year.

Education is the key to tackling both HIV and stigma. Will you make it your legacy to help people living with HIV find their voice, and to address outdated views and prejudices? With a gift in your will, you can.

Unfortunately ignorance, stigma and discrimination are still destroying lives. In the 2015 UK Stigma Survey, a shocking 50% of people living with HIV did not feel able to tell anyone of their HIV

I want to see more awareness of HIV in general, because many people don't think it's a problem any more. Statistics show a different story, and we know that the levels of diagnosis are too high.

I also want to support Terrence Higgins Trust to continue making an impact on education, welfare and counselling. But ultimately I'd like to see an end to HIV.

That's why I'm leaving a gift in my will to Terrence Higgins Trust, so their vital work can continue. But I'm also determined to keep the memory of my brother alive so, just like Terry Higgins, his death won't have been in vain.'

What your legacy gift can help us achieve

Legacies are a vital source of income and each year they help fund core services such as myHIV and THT Direct. But in the future, as we face increasing cuts in our statutory funding, legacy giving will become more and more important to our service provision. We will need supporters like you to stand with us so we really can stop HIV in its tracks.

Right now our helpline, THT Direct, is taking calls from people who often have nowhere else to turn. We could be talking to someone who has just heard the life-changing news that they have HIV, or helping to calm the fears of someone who is concerned about their sexual health. It's a vital service and costs us £456 to run each day. A gift in your will could ensure that we are able to keep answering these calls.

We also hold regular HIV support groups that provide much needed help to people who are frightened and vulnerable. Those attending share their stories, feelings and fears with one another and a trained facilitator. Not only do they discover valuable information from the group, but a new strength of mind. One of these six-week groups costs £1,008 and could be funded by a gift in your will.

We know that good sexual health education can help young people to make informed decisions around using condoms and testing for HIV. However 1 in 7 of us never had any sex education at school, and 75% of those who did rated it poor or terrible*. A gift in your will can help us campaign for a change in Sex and Relationships Education (SRE) in schools and help us continue to fight for improved sexual health in the UK long into the future.

Whatever your gift, it is a truly special act and one we will be extremely grateful for. Thank you for facing the future with us.

How you can leave Terrence Higgins Trust a gift in your will

We know that family and friends always come first. After you've ensured provision for your nearest and dearest in your will, you may be happy to consider leaving a legacy to Terrence Higgins Trust. If that's the case, there are many ways you can do so and you can make your legacy as unique as you would like.

We'd always advise you to consult with a qualified solicitor when drawing up your will, or when making amendments, as they can quide you through the legal language and ensure your wishes are clear. Typically, the types of legacy gift you might consider are:



Residuary gift

With this gift you leave a percentage share of your estate, once your family, friends and debts have been taken care of. Many people prefer residuary gifts, as leaving a percentage of the remainder of your estate is a simple way to give a gift of real value.



Pecuniary gift

This is simply a sum of money, large or small, that you wish to leave. A pecuniary gift will depreciate over time, so if you are including such gifts in your will, it may be worth reviewing their value every so often to make sure they still reflect your wishes.

Specific gift

A specific legacy is the gift of a particular item, and could be furniture, antiques or jewellery.



Legacies made on the basis of another event happening first are called contingent gifts. For example, your will could state that a gift only applies if all other beneficiaries die before you do.

Making a will doesn't have to be expensive.

For the peace of mind of knowing your wishes will be followed after your death, a will can cost as little as £85. Consulting with a gualified solicitor means your will is drawn up properly and considerately, and may even help you to minimise potential taxes, like Inheritance Tax, payable on your estate.



This is a gift that someone can benefit from in their lifetime. For instance, your house could be left for the use of a relative. When they die, it could pass to someone else, or to a charity.

Keeping up to date

Circumstances change – from buying a house to getting married, entering into a civil partnership to having or adopting children – and it is important your will reflects your current situation. It is always worth reviewing your will when there is a big change in your life to make sure it is still valid and still reflects your wishes. Reviewing your will is also an ideal opportunity to include a gift to Terrence Higgins Trust. You don't have to create a new will to do so. Sometimes all that is necessary is the addition of a codicil, a document that makes an amendment to your will without the need for it to be re-written.
